**TSA Now Accepting FFDO Applications:** The application deadline for the FFDO program is April 15th. For further information please see the April 2nd *Fastread*.

**AA Jumpseat Update:** The APA Jumpseat Committee is working with AA management toward relief from their "more onerous" JS policies, which have been in place for several years now. They ask that the Delta pilots <u>submit a JSAP</u> if an AA agent refuses a pilot's walk-up listing. <u>MEC Alert 13-03</u> details AA management's preferred listing methods. **Qualification Training:** The March bid award triggered qualification training for hundreds of pilots, and they have hundreds of questions. The DeltaNet fleet page is a good place to start looking for answers on Initial, CQ, Requal, and Recency training. The fleet "Initial Qual" link has training aids, requirements, and contacts. Other sources are your local <u>Training Committee members</u>, the FOM Part 2 (Sect. 15), the Chief Pilot, Chief Pilot Support Center, Crew Resources, and Training Planners.

**May Bid Period Adjustment:** May 2013 comes under the new definition of "bid period." The May bid period will begin on May 2nd and end June 1st. Contact the MEC Scheduling Committee at 1-800-USA-ALPA or <u>Dalscheduling@alpa.org</u> with questions.

**FAA 737 Simulator Study:** The FAA is conducting a simulator study in OKC April 15-19. Current and qualified B-737NG Captains and F/O's are needed. This non-jeopardy experience requires no study or preparation. Compensation is \$400 daily, \$99 *per diem*, and hotel reimbursement. **Pilot-to-Pilot:** P2P training will be held at the MEC office in Atlanta, April 25. P2P volunteers help bring the line pilot's perspective to their elected representatives. The MEC will cover a candidate's expenses at the meeting, but not flight pay loss.

**1040X Filing Deadline:** If you made an IRA contribution under the provisions of the FAA Modernization and Reform Act of 2012, please be advised that the deadline for filing your federal amended tax return, IRS Form 1040X, is April 15, 2013. Please review <u>*R&I Report 13-01*</u> for further guidance.

**Two Calls-to-Action - Get involved:** <u>Contact Congress</u> today to urge support for the Safe Skies Act of 2013, which call for one level of safety in passenger and cargo aviation.
