Vacancy Announcement Posted: Pilots are reminded to refer to <u>Scheduling Alert 13-03 - Filling of Vacancies</u> for information about the vacancy bidding process. As always: bid what you want, and want what you bid.

PBS Awards Changed: The PBS Working Group identified a database issue that affected the processing of "Vacation Any" for the August bid period. All preliminary bids were cancelled, the issue addressed, and all categories were processed again. The corrected results were published before the contractual deadline. The results are not final until they are posted in DBMS (iCrew).

What Happened to the Trip Mix? We received significant feedback from M88 and 320 pilots regarding the trip mix in the July and August bid periods. Crew Resources has historically worked to provide us with our preferences when credit hours and staffing allow. However, when tightly staffed and during peak flying periods there is less flexibility. The situation should improve as the peak flying tapers off and when staffing allows. **Sick Leave Verification - Important Update**: Contract Admin (CA) thanks the many pilots who have documented sick leave verification efforts with us. Your efforts help CA work with the Company on the initial implementation.

Currently, all Company requested verifications have been accepted. Voluntary submissions by pilots may or may not have been verified. Jumpseat Rules: Please be considerate of your fellow pilots. Review the rules in the FOM pertaining to Jumpseat listings aboard Delta. Jumpseats that will not be used should be cancelled *ASAP*. Multiple jumpseat listings between the same city pair on the same day are not allowed. File JSAP and FCR reports for jumpseat related issues.
